## **ADA Restoration Act Update**

On October 14 and 15 the Disability Advocacy Collaborative hosted the visit to Connecticut of the Road to Freedom Tour. The purpose of the Tour was to celebrate the disability rights movement and to educate the public about the need for the ADA Restoration Act. Here is a brief overview of the hearing on the proposed Act that was held in Washington, DC on November 15, the day the Tour concluded its fifty state odyssey:

The November 15 ADA Restoration Act hearing in the Senate Health, Education, Labor, and Pensions (HELP) Committee delivered a strong message to the Congressional record of its need.

Senator Harkin (D-IA), the lead sponsor of the Senate bill, [S.1881](#), began the hearing by addressing his involvement with the original ADA, what Congress intended, and some of the Supreme Court decisions that have brought us way off course with this great law.

Long time disability rights leader John Kemp, attorney in Washington, D.C., was first to speak from the panel. Mr. Kemp spoke of his personal experience having grown up without arms or legs and stated that disability discrimination is "un-American."

Dick Thornburgh, Attorney General under Former President George H.W. Bush, like Senator Harkin, spoke of his role in the passage of the original ADA and what he understood Congress's intent to be.

Steven Orr, a pharmacist with Type 1 diabetes from South Dakota, spoke next. Mr. Orr, who wears an insulin pump, detailed his experience of discrimination by his employer who flat out told him he was firing him because of his diabetes but who nonetheless lost his case when the Courts determined that he was not "disabled" for purposes of the ADA's protections.

Camille Olson, an attorney and professor from Chicago, offered an oppositional viewpoint. While noting all the progress in the workplace to date on account of the ADA, Ms. Olson argued that the ADA Restoration Act of 2007 is not a suitable solution to address concerns with the ADA, arguing that the legislation included too many people with all varieties and severities of impairments in its protections.

### **Disabilities Show on “Connecticut Newsmakers”**

On Sunday, November 25, West Hartford Chief William Austin and Theresa Nadeau, a member of the disability community and a spokesperson for people with disabilities, will appear on Ch. 30's Connecticut Newsmakers at 6:30 a.m. Both are being interviewed by Tom Moynihan on the topic of Disabilities Registration Programs for Municipalities. The program will be re-broadcast at 9:15 p.m. Sunday on Connecticut Network (CT-N).

Chief Austin will discuss the importance of communities implementing a Disabilities Registration Program and will cite West Hartford's experiences--both pro and con--surrounding that town's registration program. Ms. Nadeau will discuss the importance of having people with disabilities participate in these programs, encouraging some to overcome their reluctance to register for concerns of confidentiality.

## **Transition to Adulthood: A Critical Milestone**

The Connecticut Department of Public Health and the United Way of Connecticut / 2-1-1 Child Development Infoline are sponsoring a conference on “transitions” on December 6 from 8:30 am – 3:30 pm at the Sheraton Four Points in Meriden. For the purpose of this conference, transition is defined as the deliberate, coordinated provision of developmentally appropriate and culturally competent health assessments, counseling and referrals. A critical component involves children, families and providers acquiring the required skills to transition those children to adulthood and allow them to manage their own condition and their lives.

Workshop topics will include transitioning from:

- ◆ Pediatric to adult medical services
- ◆ Pediatric to adult behavioral health services
- ◆ School to work

In addition to human service workers the conference is recommended for young adults and their families. Members of CT-KASA (Kids As Self Advocates) will be part of all three panels of experts.

## **Charter Oak Plan**

Last December Governor M. Jodi Rell proposed a new Charter Oak Health Insurance Plan to address what many call the toughest challenge in health care nationally—bringing health care coverage to uninsured adults of all incomes. The intent of the new plan is to develop a private-public partnership offering health insurance at an affordable group rate.

According to the Governor, the Charter Oak Health Insurance Plan would benefit uninsured adults of all incomes who do not have insurance through the workplace by providing basic, quality health insurance to individuals age 19 to 64 -- people who range from young adults who are no longer eligible for their parents’ health policies to older adults who are not yet eligible for Medicare.

In response to inadequacies in the plan as has evolved to date, a coalition has been formed under the leadership of Sheldon Toubman, an attorney at New Haven Legal Assistance. The coalition has discovered the following deficiencies in the Governor’s plan:

- lack of inclusion of consumer mandates and external appeals
- high co-pays
- annual maximums (DME - \$2000 - and medication - \$2500)
- lack of public input
- lack of any monitoring once plans are in operation

The Disability Advocacy Collaborative has joined the coalition, and urges any concerned citizen to contact Sheldon to stay on top of the situation; he can be reached at [stoubman@nhlegal.org](mailto:stoubman@nhlegal.org) . A public hearing on the plan is being considered, and will possibly be held during the first week of December.

**It's Time to Apply for YLF 2008!**

Karen Halliday, Executive Director of the Connecticut Youth Leadership Program, has announced that applications are available now in Connecticut high schools for the 2008 Youth Leadership Forum. The Forum, in its 10<sup>th</sup> year, will bring together forty high school students with disabilities from throughout Connecticut for a four-day training forum focusing on enhancing their leadership skills. YLF is open to current high school sophomores and juniors. It will be held July 21 – July 24, 2008 at the University of Connecticut, Storrs campus.

### **Moratorium on Utility Service Shut-offs**

Governor Rell has reminded Connecticut residents that as the rising price of oil continues to affect everything from gasoline to home heating oil, there is a moratorium on utility service shut-offs. "If a resident is below 150 percent of the federal poverty level, they cannot be refused gas and electric service because of lack of payment from November 1 through April 15," the Governor said.

### **News on Earned Income Tax Credit**

EITC is a special tax benefit for working people with low to moderate incomes. You may be able to claim from \$100 to more than \$4,000, depending on income, marital status and number of children. The EITC is not counted as income in most public benefit programs, including SSI, Medicaid, Food Stamps, Veterans Benefits, and Federally Assisted Housing.

### **News from Justice for All**

Disability organizations and advocates are encouraged to support H.R. 3985, The Over-the-Road Bus Transportation Accessibility Act of 2007. This bill would address the problem of private intercity bus companies without stations, known as curbside carriers, that ignore the ADA. These companies, which use high-floor "over-the-road" buses and offer budget fares along the Eastern seaboard and across the country, do not provide accessible buses and have frequently discriminated against people with disabilities by, for example, denying transportation to blind people with guide dogs or requiring them to sit in the last row of the bus.

HR 3985 would require the Federal Motor Carrier Safety Administration (FMCSA), the office at DOT that licenses and regulates privately-operated bus carriers, to fully consider ADA compliance when it grants and revokes operating authority to passenger motor carriers. FMCSA has repeatedly stated that it won't, or can't, consider ADA compliance in its licensing decisions, despite a U.S. Court of Appeals decision from the DC Circuit last year asking DOT to do so.

HR 3985 does not amend the ADA, but rather, amends the law that gives FMCSA its authority, adding the DOT ADA regulation to the list of items FMCSA must consider in granting and revoking operating authority. It also requires FMCSA implementation in 30 days and a coordinated enforcement agreement between FMCSA and the Department of Justice in six months.

This bill was passed unanimously on October 31 by the House Transportation and Infrastructure Committee.

### **News on Community Choice Act**

ADAPT has reported that Representative John Dingell, Chair of the Energy and Commerce Committee, and Representative Frank Palone, Chair of the Subcommittee on Health, have committed to hold a hearing on the Community Choice Act as the first act of the Health Subcommittee in the new Congressional session. Stay tuned for the exact date.

The Community Choice Act provides an alternative to institutionalization and will fundamentally change our long term care system and the institutional bias that now exists. Building on the Money Follows the Person concept, the two million Americans currently residing in nursing homes and other institutions would have a choice. In addition, people would not be forced into institutions in order to get community services; once they are deemed eligible for the institutional services, they will be able to choose where and how they receive services. Instead of making a new entitlement, the Community Choice Act, makes the existing entitlement more flexible.

The Senate version of the Community Choice Act is [S. 799](#) and the House Bill is [H.R. 1621](#) .

### **Report on Presidential Candidates' Forum of November 2**

The transcript of "A National Forum on Equality, Opportunity, and Access," the presidential candidate forum that took place in Manchester, NH on November 2, is now available on the [AAPD website](#). Over 600 New Hampshire voters with disabilities attended the day-long, first-ever cross disability presidential forum. Five candidates arrived in person to share their positions on a variety of disabilities. These included Senators Clinton, Biden, Dodd, Gravel, and Representative Kucinich. One candidate (Edwards) sent a surrogate, and Senator McCain joined via a phone call.

Kids As Self Advocates (KASA) has announced the publication of its newest report - "Standardized Testing: What Youth with Disabilities Have to Say".

This report shares:

- Youth voice - including many quotes from youth

- Cutting edge ideas to improve test accessibility and knowledge of rights
- How standardized testing has affected people with disabilities in history
